Assesses 10+2 level understanding across core disciplines

Subject	Questions	Marks	Topics
Mathematics	3	3	Number systems, HCF/LCM, fractions, decimals, ratios, percentages, average, profit & loss, simple & compound interest, basic algebra, geometry (area, perimeter, volume)
General Knowledge	9	9	Current events (national/international), Nepal's history & geography, science & technology, sports, awards, politics, economy
Logical Reasoning	9	9	Number/letter series, analogy, classification, direction & distance, ranking, Venn diagrams, data sufficiency, logical word sequences

1. *English*: "Choose the correct synonym of 'abundant'." → **Plentiful**
2. *Math*: "If 20% of $x = 40$, then $x = ?$ " → **200**
3. *GK*: "Which is Nepal's largest hydroelectric project?" → **Upper Tamakoshi**
4. *Reasoning*: "Find the missing number: 2, 4, 8, 16, ?" → **32**

3. Part II: Program-Specific Subjective (30 Marks)

Evaluates program-relevant knowledge and critical thinking

A. BALLB (Law & Governance)

Question Model: 3 questions × 10 marks = 30 marks

Question	Topic	Sample Prompt
Q1	Nepali Language Composition : Constitutional Law	"Describe the fundamental rights guaranteed under the Constitution of Nepal (2015). Discuss their significance in a federal democracy." Write in Nepali Language
Q2	English Language : Jurisprudence	"Define law. Explain the nature and scope of jurisprudence. How does law regulate social behavior?"

Question	Topic	Sample Prompt
Q3	Civil/Criminal Law(Any language Nepali/English)	"Explain the key elements of a valid contract under the Contract Act. Differentiate between civil and criminal liabilities."

Focus Areas:

- Legal reasoning, case analysis, constitutional provisions, human rights, Nepalese legal system.

Part II: Common Subjective for BBA & BPAM (30 Marks)

Evaluates 10+2 level understanding in business, management, economics, and governance—relevant to both programs

Question Model: 3 questions × 10 marks = 30 marks

Language: English or Nepali

Duration: 90 minutes

Question	Topic	Sample Prompt (Common for BBA & BPAM)
Q1	Management & Organization	"What is management? Explain the functions of management (planning, organizing, leading, controlling) with examples. How do these functions apply in both business organizations and public sector institutions?"
Q2	Economics & Nepal's Context	"Discuss the basic concepts of demand and supply. Explain how market forces work. Analyze the challenges faced by small businesses and public service delivery in Nepal."

Question	Topic	Sample Prompt (Common for BBA & BPAM)
Q3	Ethics, Accountability & Governance	"What is accountability? Explain the importance of ethics in both business and public service. Discuss mechanisms to ensure transparency and prevent corruption in organizations and government institutions in Nepal."

Question	Topic	Sample
Q.1	Contextual	What is the scope of your chosen field of study ?
Q.2	Case analysis	Which aspects of organization is more important for national growth & development technology or management ? Why?
Q.3	Nepali government services	Explain any one public service delivery.
Q.4	Attitude	Why you want to study at Madhesh University

10th Grades	2 marks	Overall percentage: $\geq 75\%$ = 2, 65–74% = 1.5, 55–64% = 1, $< 55\%$ = 0
Extracurriculars	2 marks	Leadership roles, competitions, volunteering, certificates (verified documents)

B. Interview/Viva Voce (10 Marks)

Criterion	Marks	What Panel Evaluates
Communication Skills	3	Clarity, fluency (English/Nepali), confidence
Program Motivation	3	Understanding of program, career goals, relevance
Critical Thinking	2	Logical reasoning, problem-solving approach
Ethical Awareness	2	Values, integrity, social responsibility

Sample Interview Questions:

- **BALLB:** "Why do you want to study law? What social issue do you think law can best address?"
- **BBA:** "What business would you start after BBA? How will you manage risks?"
- **BPAM:** "What is public service? Why is accountability important in government?"

5. Selection Criteria & Merit List

Written Exam (Objective + Subjective)	80% (80 marks)
Interview + Past Performance	20% (20 marks)

Minimum Qualifying Scores:

- Written Exam: $\geq 40/80$
- Interview: $\geq 6/10$
- Overall: $\geq 50/100$

6. Eligibility Requirements

Program	Qualification	Minimum Grade
BALLB	10+2 (Any stream) or equivalent	50% overall or C+ GPA in each subject
BBA	10+2 (Any stream) or equivalent	40% overall or 1.6 + CGPA in each subject
BPAM	10+2 (Any stream) or equivalent	40% overall or 1.6+ CGPA in each subject

Additional Notes:

- Foreign qualifications require equivalence certificate.

7. Application & Examination Process

Step-by-Step:

1. **Submit Application:** Online portal (forms available at madheshuniversity.edu.np)
2. **Pay Fee:** As specified in admission notice
3. **Receive Admit Card:** Download 7 days before exam
4. **Take Written Exam:** 2 hours (Objective + Subjective) at designated center
5. **Interview:** Shortlisted candidates (top 50% by written score) invited within 7 days
6. **Merit List Published:** University website + notice board
7. **Admission Confirmation:** Within 7 days of merit list publication

Required Documents for Admission:

- Original mark sheets (10th + 10+2)
- Character certificate from last institution
- Passport-sized photos (4 copies)
- Extracurricular certificates (if claiming points)
